

1. Product


Everlux EXIT Sign – model number C0012 - with optional directional chevrons.



2. Product Description

This sign is manufactured with a strong 1mm thick aluminum base coated with a photoluminescent pigment of high luminous intensity. The sign features an antistatic and easy to clean surface protected with a transparent film.





The product is supplied with two red color self-adhesive directional chevrons.

The sign is supplied with two self-adhesive red color directional chevrons that can be used to show the direction of travel to the exit as necessary in the possible options shown below:



Without the use of the directional chevrons



Using a directional chevron to the left



Using a directional chevron to the right



Using directional chevrons to both left and right

Note: The adhesive backing used in the directional chevrons is a product that complies with the Standard for Marking and Labeling Systems - UL 969.

3. Quality and Certification

4. Technical Information / Dimensions

- 1/32" thick aluminium
- High photoluminescent luminous intensity
- No power required Photoluminescent fully charges during exposure for 60 minutes to a fluorescent lamp at least 5ft-c illuminance (54lux)
- Maximum Visibility Distance: 50 feet (15.25m)
- Designed for surface and flag (for wall) or ceiling mounting
- Single sided or double sided installation
- The sign will be provided with 4 holes
- Size: 15 3/4" W x 9 3/8" H
- Weight: 0.88 lb

5. Brightness Rating (Luminance Properties)

According to UL 924

According to UL 924, in stimulation conditions of 54 lux (5 ft-c) during 60 min with a fluorescent cool white source color temperature 4000K, the UL listed **Everlux** EXIT sign will deliver the following luminance performance:

6. Installation

The sign features 4 holes and is supplied with 4 bolts and 4 plugs which can be used for a direct wall installation:



A silver frame is also available and can be supplied, on order, with the respective installation accessories for ceiling and wall (single or double-sided) installation.

7. Dimensions, Pictograms and Colors

The products are in conformity to the **Everlux** catalogue and in compliance with National and International Standards, Codes and Legislation.

8. Printing

Silk Screen Printing: high quality gloss paint with UV resistance.

9. Washability

The sign can easily be cleansed with a dry cloth or with a cloth humidified with water (without detergents).

10. Toxicity

The product does not contain any radioactive substances. In toxic terms the product is considered as safe (European standard EN 71-3).

11. Warranty

In normal conditions of mounting and adequate cleanness and maintenance, the sign is covered with a 5-year warranty against manufacturing defects.

For outdoor applications, considering exposure to varying temperatures, humidity and other extreme environments, the warranty can be diminished.

On wet environments or environments with the presence of water with strong acid or alkaline content (eg limestone and chlorine the warranty can be diminished.
